About University

The Nanaji Deshmukh Veterinary Science University, Jabalpur was established on 3rd November 2009, under the Act No. 16 of the Madhya Pradesh Pashu Chikitsa Vigyan Vishwavidyalaya Adhiniyam, 2009 with the objectives to impart education in different branches of Veterinary, Fisheries and allied sciences, for the advancement of learning and prosecution of research in Veterinary and Fisheries Sciences; and to undertake the extension of such sciences to the rural people in co-operation with the State Veterinary Department. The ICAR has accredited post graduate programmes of College of Veterinary Science & A.H., Jabalpur, Mhow and Rewa. The undergraduate programme of all the three campi has been accredited by the council. The well-established University has Faculty of Veterinary Science and Animal Husbandry under which three Veterinary Colleges are located at Jabalpur, Mhow and Rewa and a College of Fisheries Science, located at Jabalpur. Along with this Animal Biotechnology Centre and School of Wildlife Forensic and Health, are also located at Jabalpur. College of Veterinary Science and Animal Husbandry, Jabalpur, established on July 8, 1948, has transformed over the years from the modest beginning in small hutments into full-fledged Veterinary University. College of Veterinary Science and Animal Husbandry, Mhow was established on 12th July 1955. The alumni of colleges have created an impeccable impact not only in our country but in other countries also. Both the colleges became constituent units of the Jawaharlal Nehru Krishi Vishwa Vidyalaya, Jabalpur, on 2nd October 1964. The College of Veterinary Science and Animal Husbandry, Rewa, came into existence in the year 2007, as a constituent unit of Jawaharlal Nehru Krishi Vishwa Vidyalaya, Jabalpur. These three Veterinary colleges became constituent units of NDVSU when it was carved out of JNKVV in the year 2009. The colleges, today, have a full complement of the state-of-the-art laboratories in 17 departments, each under the guidance of highly qualified and experienced team of faculty / scientists. The College of Fishery Science, Jabalpur was established in the year 2012.

1. Admission for Post Graduate Diploma in Wildlife Health Management:

- i. Admission in post graduate diploma programme in Wildlife Health Management shall be on the basis of OGPA / percentage of marks in B. V. Sc. & A.H. examination.
- ii. In cases where, two or more candidates obtained equal OGPA / percentage of marks in B. V. Sc. & A.H. examination, the inter-se-merit of such candidates shall be determined in order of the following preference:
 - a. In cases where, the OGPA / percentage of marks in B. V. Sc. & A.H. are same, then inter-se-merit of such candidates shall be prepared on the basis of percentage of marks in Higher Secondary School Certificate Examination (12th standard).
 - b. In cases where, the percentage of marks shall be same in Higher Secondary School Certificate Examination, the inter-se-merit of such candidates shall be prepared on the basis of age of the candidates. The candidate having more age shall be higher in merit followed by candidates having lesser age.

2. Admission for Post Graduate Diploma in Small Animal Surgery

- i. Admission in post graduate diploma programme in Small Animal Surgery shall be on the basis of OGPA / percentage of marks in B. V. Sc. & A.H. examination.
- ii. In cases where, two or more candidates obtained equal OGPA / percentage of marks in B. V. Sc. & A.H. examination, the inter-se-merit of such candidates shall be determined in order of the following preference:
 - a. In cases where, the OGPA / percentage of marks in B. V. Sc. & A.H. are same, then inter-se-merit of such candidates shall be prepared on the basis of percentage of marks in Higher Secondary School Certificate Examination (12th standard).
 - b. In cases where, the percentage of marks shall be same in Higher Secondary School Certificate Examination, the inter-se-merit of such candidates shall be prepared on the basis of age of the candidates. The candidate having more age shall be higher in merit followed by candidates having lesser age.

3. Admission for Post Graduate Diploma in One Health

- i. For admission in PG Diploma in One Health, a bachelor's degree in Veterinary Science (B.V.Sc. & A.H.) / Medical Science (MBBS) or Master's in Life Sciences is mandatory.
- ii. Admissions will be done on the Basis of percentage of marks in Higher Secondary School Certificate Examination (12th Standard) either State / Central Board.
- iii. In cases where, two or more candidates obtained equal OGPA / percentage of marks in 12th Standard examination, the inter-se-merit of such candidates shall be determined on the basis of age of the candidates. The candidate having more age shall be higher in merit followed by candidates having lesser age.

4. **Admission for Post Graduate Diploma in Forensic Science**
- For admission in PG Diploma in Forensic Science, a bachelor's degree in Veterinary Science (B.V.Sc. & A.H.) or Master's in Life Sciences is mandatory.
 - Admissions will be done on the Basis of percentage of marks in Higher Secondary School Certificate Examination (12th Standard) either State / Central Board.
 - In cases where, two or more candidates obtained equal OGPA / percentage of marks in 12th Standard examination, the inter-se-merit of such candidates shall be determined on the basis of age of the candidates. The candidate having more age shall be higher in merit followed by candidates having lesser age.

5. **Admission for Post Graduate Diploma in Livestock Business Management**

- For admission in PG Diploma in Forensic Science, a bachelor's degree in Veterinary Science (B.V.Sc. & A.H.) or Master's in Life Sciences is mandatory.
- Admissions will be done on the Basis of percentage of marks in Higher Secondary School Certificate Examination (12th Standard) either State / Central Board.
- In cases where, two or more candidates obtained equal OGPA / percentage of marks in 12th Standard examination, the inter-se-merit of such candidates shall be determined on the basis of age of the candidates. The candidate having more age shall be higher in merit followed by candidates having lesser age.

6. **Reservation of seats**

Reservation of seats shall be governed by the existing rules / policy of the State government of Madhya Pradesh.

6. The proposed dates are tentative. If there is any change it will be notified through university website.
7. Candidate should ensure eligibility before applying.
8. Candidate selected for admission on merit basis by NDVSU may seek admission only during the session for which applications are being called.
9. The availability of seats in different Post Graduate Diploma programmes is given in point no.18.

9. **Last Date for submission of application form**

Two copies of the Application Form complete in all respects has to be submitted to the office of the Director of Instruction, Nanaji Deshmukh Veterinary Science University, Administrative Block, Adhartal, Jabalpur 482004 by Registered / Speed Post or by hand so as to reach the office of the Director of Instruction on or before the last date of submission of Application Form i.e. **11-11-2026 up to 5:00pm**. Application Forms received after due date or without requisite fee will not be accepted.

10. **Mode of selection**

Admission to post graduate diploma programmes, shall be on the basis of merit list prepared as mentioned in S.No. 03-07. In the first counseling, only candidates of NDVSU /

domiciles of Madhya Pradesh can participate. In the second counseling, both candidates of NDVSU / domiciles of Madhya Pradesh and other state candidates can participate.

11. Residential requirement and maximum permissible time limit for completion of post graduate degree will be as per Post Graduate academic rules and regulations 2024-25.

12. Medium of instruction

The medium of instruction shall be English for all post graduate diploma programmes.

13. Hostel facilities

Moderately furnished single/ double seated rooms in limited number are available in hostels, both for boys and girls. Electricity bill shall have to be paid by the students as per rules for consumption of energy/ electricity, other than hostel fees etc.

14. Admission for enrolment

- i. Candidates selected for admission shall be required to show all the original certificates and mark sheets on the day of document verification, to fulfill the minimum requirement for admission. Two separate sets of self-attested photocopies of the following documents have to be submitted:
 - a. Mark sheet of each examination, from HSSC exam on wards
 - b. Certificate of date of birth
 - c. Migration certificate and Transfer certificate
 - d. Other certificates/ testimonials.
 - e. Submission of Provisional Degree Certificate (PDC) on the day of counseling shall be essential, without which, candidate shall not be allowed for counseling and admission in any programme of the University.
- ii. After verification of documents the candidate has to deposit the enrolment and admission fees along with other fees as notified by the University, in the office of the Dean / Director, of the College / Centre / School, to which student is admitted.
- iii. If the candidate fails to deposit prescribed fees within due date, his/ her admission shall be treated as cancelled and the vacant seat shall be allotted to other candidate on the basis of merit.
- iv. Once the candidate accepts admission, he/ she will be Bonafide student of the NDVSU and he/ she would thereafter be governed by all the rules and regulations applicable in the university.

15. Registration

A selected candidate after payment of his / her fees for admission shall get himself/ herself

registered in person within the prescribed date. No candidate under any circumstances shall be permitted to register himself / herself after the expiry of date or stipulated time, in first and subsequent semesters, as notified from time to time. He /she has to pay all the fees on the date of registration in every semester. If the student fails to register his / her courses in stipulated time his / her admission would be cancelled.

16. Cancellation of admission:

If it is found at any stage that candidate has obtained admission by suppression or false presentation of facts, his/ her admission shall be liable to automatic cancellation. In such case no refund of fees shall be allowed.

17. Withdrawal from University:

A student who desires to get withdrawal from the University has to apply in writing for a withdrawal certificate, to the Director of instruction, through the Dean of the College /Director of Centre/ School, which shall be granted to him/ her on clearance of all his/ her dues of the University.

- Eligible candidates should attend the counseling as per the specified schedule. The candidates appearing in the counseling must bring the original copies of certificate of qualifying examination and other testimonials.
- List of candidates eligible for counseling will be uploaded on the University website www.ndvsu.org. No separate intimation will be sent for counseling.
- Absentees for any reason whatsoever will not be considered for admission.
- During counseling, the candidates will be called in order of merit.
- The selected candidate must deposit entire prescribed fee on due date, failing which his/her admission shall stand cancelled.
- Dates of counseling will not be changed under ordinary conditions, even if it is declared a holiday.
- The academic council of the university is the supreme academic authority to frame rules and regulations, increase/decrease the admission capacity and categories and to decide all other matters relating to admissions and academic affairs. The academic council also has the right to promote or discontinue any programme whatsoever.
- All the programmes of the university are full time programmes. A student admitted in any post graduate programme of this University cannot study in any other programme in any University.
- At the time of counseling the selection committee shall also consider the past record of the candidate as a student in the university or elsewhere, if it is found that candidate being considered for admission has been involved in acts of indiscipline in College/School/Hostel or organizing demonstration etc., the selection committee may refuse admission to such a candidate and the decision of selection committee shall be final. The student who has been expelled/rusticated or debarred by any university shall not be admitted.
- Hiding of facts whatsoever may attract disqualification of a candidate, if they so warrant, whatsoever such facts come to light even during the course of study.
