1. Eligible candidates for admission in B.V.Sc. & A.H. and B.F.Sc. degree courses under quota for wards of Kashmiri Migrants and Kashmiri Pandits / Kashmiri Hindu Families (Non-migrants) living in Kashmir valley should carefully read the rules for admission before submitting the application form. **Incorrect/false information may lead to cancellation of application form for admission and the candidate will be liable to face legal action.**
2. Admission will be made as per the merit list to be prepared on the basis of marks obtained by candidates in the NEET (UG)-2026 conducted by National Testing Agency (NTA). Only NEET (UG)-2026 qualified candidates are eligible for admission in B.V.Sc. & A.H.
3. The prescribed application form for admission may be downloaded from **www.ndvsu.org**
4. The 2nd counseling under this quota seats will be held at Nanaji Deshmukh Veterinary Science University, Kartavya Bhawan,, Adhartal, Jabalpur, Madhya Pradesh-482004 (India) on **29th September, 2026 (11:00 a.m.)**. **The personal presence of the candidate is essential alongwith the duly filled application form and original documents/ testimonials on the day of counseling as mentioned in Rule No.18 and also proof of application fees of non-refundable application fee of Rs. 2000/- (Two thousand rupees), else he/she will not be considered for counseling and admission.**
5. The candidate must have attained 17 years of age on 31st December, 2026.
6. The candidate must have passed 12th class from a “recognized/ approved Board of School Education having equivalence by Council of Boards of School Education (COBSE), New Delhi/CBSE/ICSE with Physics, Chemistry, Biology and English subjects and obtained minimum 50% marks in science subjects (Physics, Chemistry and Biology) in aggregate.
7. Relaxation in cut-off percentage upto 10% subject to minimum eligibility requirement.
8. The candidates applying under Kashmiri Migrants will have to produce a certificate in the support of their claim issued by Divisional Commissioner/ Relief Commissioner. The domicile certificate is not required for Kashmiri Migrants.
9. Kashmiri Pandits / Kashmiri Hindu Families (Non-migrants) living in Kashmir valley need domicile certificate.
10. No application form for admission will be considered unless it is accompanied by self attested copies of the documents/ testimonials.
11. No changes will be entertained once the application has been submitted.

12. The counseling under Kashmiri quota seats will be held at Nanaji Deshmukh Veterinary Science University, Adhartal, Jabalpur, Madhya Pradesh-482004 (India). The personal presence of the candidate alongwith original documents/ testimonials on the day of counseling is compulsory, else he/she will not be considered for admission.

At the time of admission, the candidate has to submit a notarised surety bond on non-judicial stamp paper of Rs. 200 stating that in case of leaving the study anytime after admission due to any reason including shortage of attendance before completion of B.V.Sc. & A.H. programme, the student will refund the total drawn amount of stipend from the college (if any) alongwith a sum of Rs. 1.00 Lakh (one lakh Rupes only) as penalty to get College Leaving Certificate and Migration Certificate.
20. Transfer of students admitted under this quota seats from NDVSU, Jabalpur to a Veterinary College of other State shall be permitted as per Academic rules only on payment of the remaining fees of the entire degree programme.
