- The candidates physically present on the day of counselling will only be considered for counselling and admission as per merit of NEET (UG)-2025 conducted by National Testing Agency (NTA) as mentioned in the application form subject to fulfilment of eligibility criteria.
- In case of admission, you have to deposit the prescribed fees of Rs. 73860/- at the time of admission (cash will not be accepted) on the same day, failing which your admission will be cancelled. For hostellers, an additional fees of Rs. 21000/- has also to be submitted.
- In case of admission, you have to submit a notarised surety bond on non-judicial stamp paper of Rs. 100 stating that in case of leaving the study anytime after admission due to any reason including shortage of attendance before completion of B.V. Sc. & A.H. programme, the student will refund the total drawn amount of stipend from the college (if any) alongwith a sum of Rs. 1.00 Lakh (One lakh Rupees only) as penalty to get College Leaving Certificate and Migration Certificate. The proforma of bond will be provided to the admitted candidates at the time of counselling.
