Memorandum of Understanding

Between

Nanaji Deshmukh Veterinary Science University, Jabalpur

And

Gou Vigyan Anushandhan Kendra, Deolapara

The Nanaji Deshmukh Veterinary Science University, Jabalpur, (NDVSU), Jabalpur and the Gou Vigyan Anushandhan Kendra, Deolapara have realized the need for close linkages in terms of research and academic activities. In compliance to this idea, the Nanaji Deshmukh Veterinary Science University, Jabalpur (henceforth called as NDVSU) and Gou Vigyan Anushandhan Kendra, Deolapara are desirous of signing a memorandum of understanding (MoU) on November, 2018 to strengthen their academic, research and extension programmes.

Terms and conditions of MoU

- The collaboration between Gou Vigyan Anushandhan Kendra, Deolapara and Nanaji Deshmukh Veterinary Science University, Jabalpur shall be established in the area of mutual interest of both the institutions for strengthening teaching, research and extension activities for undergraduate and postgraduate students.
- NDVSU and Gou Vigyan Anushandhan Kendra, Deolapara will undertake advanced research in subjects/ areas related to indigenous cow urine, cow dung and panchagavya products.
- NDVSU and Gou Vigyan Anushandhan Kendra, Deolapara will work towards joint research projects for developing new products/technologies thereby, mutually using research facilities, support of its human resource and their technology knowledge at NDVSU and Gou Vigyan Anushandhan Kendra, Deolapara
- NDVSU and Gou Vigyan Anushandhan Kendra, Deolapara, may coordinate joint meetings for providing services, animal health camps and awareness training programmes for farmer and livestock owners.
- Data generated/innovations through such collaborative research will be patented/published jointly by scientist/members of both the parties on mutually agreed terms.
- The MoU shall remain valid initially for a period of 2 years from the date of signing and shall be extended further on mutual consent.
- The IPR/Commercialization/publication of the research outcomes will be decided jointly by both the Institutes by the mutual consent through the Monitoring Committee.

- Neither of the parties believes that the collaboration contemplated by this MoU raise any actual or potential conflicts of interest. The parties agree that this MoU and the negotiation of the same (and any other agreements entered into in connection herewith) are independent of any past, present or potential future arrangements, and are not connected to an existing business relationship between either of the parties.
- This MoU shall also terminate without liability to either party if otherwise agreed to by the parties in writing with a notice period of 1 month.
