## **MEMORANDUM OF UNDERSTANDING**

### Between

Nanaji Deshmukh Veterinary Science University, Jabalpur and State Veterinary Hospital, Bhopal, Department of Animal Husbandry, Govt of M.P.

The Nanaji Deshmukh Veterinary Science University (NDVSU), Jabalpur and the State Veterinary Hospital, Bhopal (SVHB), Department of Animal Husbandry, Govt. of M.P. have realized the need for close linkages in terms of research and academic activities. In compliance to this idea, the Nanaji Deshmukh Veterinary Science University, Jabalpur (henceforth called as NDVSU) and State Veterinary Hospital, Bhopal, Department of Animal Husbandry, Govt of M.P. (henceforth called as SVHB) are desirous of signing a Memorandum of Undertaking (MoU) on Desperation February, 2018 to strengthen their academic, research and extension programmes.

### Terms and conditions of MoU

- The collaboration between State Veterinary Hospital, Bhopal and Nanaji Deshmukh Veterinary Science University, Jabalpur shall be established in the area of mutual interest to both the institutions for strengthening teaching, research and extension activities of UG and PG students; faculty and field veterinarians.
- Interns of all three constituent veterinary colleges from Jabalpur, Mhow & Rewa shall be attached to SVHB for 15 days on rotation basis for exposure to clinical internship training.

- The PG scholars may be assigned their research work on clinical cases at SVHB
  with the available diagnostic and therapeutic facilities, under the supervision of
  Major Advisor from NDVSU. One expert in the area of subject shall be from
  SVHB as member of advisory committee.
- 4. The infrastructure, instruments, and laboratory facilities available at SVHB shall be extended to the PG students. The students may work under the supervision of In-charge Veterinarians at SVHB and shall not be held responsible for any damage to equipments/instruments but student should have to sign an undertaking for carefully handling on precious equipments/instruments
- 5. The NDVSU shall extend its infrastructure, laboratory, instrumentation, library facilities and technical know-how to State Veterinarians, accomplishing collaborative teaching / research / training programmes of common interest.
- 6. Data generated through such collaborative research will be patented/ published jointly by scientists/members of both the institutions on mutually agreed terms.
- 7. No staff member on full time basis shall be provided by the University for monitoring the students at SVHB for the internship programme. However internship In-charge can visit SVHB, as and when required.
- 8. No staff member shall be provided from the University for handling the equipments and/ or treatment of cases at SVHB.
- 9. The implementation and regulation of MoU shall be monitored by the Hon'ble Vice Chancellor, Nanaji Deshmukh Veterinary Science University, Jabalpur and Director, Department of Animal Husbandry, Govt. of M.P. from time to time and any interim modification /alteration necessary shall be brought into force.
- 10. The MoU shall remain valid initially for a period of 2 years from the date of signing and shall be extended further on mutual consent.
- 11. The students shall be provided suitable free accommodation by SVHB.
